Namhlanje, **nge-24 ku-Okthobha 2025**, i-ERM CVS ibhengeza ukuba ngomhla **we-18 ukuya ku-20 kuNovemba 2025** iza kutyelela imayini iValterra Platinum Amandelbult ekwiPhondo laseLimpopo, eMzantsi Afrika, ukuze yenze uPhicotho loLawulo lwe-Initiative for Responsible Mining Assurance (IRMA) uPhicotho loQinisekiso loLawulo oluzimeleyo (surveillance assessment) olwenziwa liqela lesithathu elizimeleyo lokujonga nokuvavanya ukusebenza kwemigodi enoxanduva.

Uphicotho-zincwadi lokucupha kwisiza luya **kuqinisekisa ukuba imisebenzi yesiza iyaqhubeka nokuhambelana nomsebenzi owawuvunyiwe ngaphambili kwingxelo yophicotho-zincwadi lokuqala**. Iqela lophicotho-zincwadi liya kuqinisekisa ukuba iinkqubo nolawulo lomgodi zisasebenza kwaye zisebenza ngokufanelekileyo, akukho lutshintsho lukhulu lwenzekayo oluchaphazela kakubi ukusebenza komgodi, nokuba isiza siqhubela phambili kwisicwangciso saso sokulungisa. Olu phicotho luya kubandakanya iingxoxo eziyimfihlo kunye nabasebenzi kunye nokubonisana nabachaphazelekayo basekuhlaleni. Emva kokugqitywa kophicotho lokongamela, ingxelo iya kupapashwa kwiwebhusayithi ye-IRMA.

Ingxelo emfutshane yophicotho lokongamela (abbreviated surveillance audit summary report) iya kunika iValterra Platinum nakwabachaphazelekayo umbono wokuba imisebenzi iyaqhubeka njani, utshintsho olubalulekileyo olwenziweyo, kunye neengxelo ezibonisa ukuphucuka okuqhubekayo. Uphicotho olupheleleyo lokuphinda luhlolwe luza kwenzeka kwiminyaka emithathu emva kokupapashwa kwengxelo yokuqala yophicotho.
